Minnesota Higher Education Services Office information

I have been notified by the MHESO relating to their laws in this state. They state that "anyone who teaches anything in the state of Minnesota which is over 16 hours and is intended to be vocational, needs to be licensed and registered as a school with the State of MN." Even if the instructor is out of state and teaches here, they are still required to be a school. The job of starting a school is daunting (to me), and costly. I am pursuing different options, including teaching through Anoka Ramsey's Integrative Healing Department, and that seems to be a go for the spring of 2005, but I am still working on how to teach the Certification Program and Masters Program this November and December. This law will affect many of you, which is also why I'm considering the school option where many of us could teach under the umbrella of Golden Visions Center's Non-Profit School. Any thoughts?

Hypnosis” ... please email me if you have any questions. I still have to find out if this will affect me personally, as I am out of state. We shall see.
